I received your letter about my late fee. There has been a mix up with the two corporations that I own. Let me start from the beginning.

I have two corporations with the State of Florida. Stripes Paving and Rockwell Pipe Supply. I did not receive your first notice for filing because it was sent to the wrong address. The second notice I received by luck and called you about the mix up. Your office told me to write a letter explaining to one location and the three hundred dollars for both corporations to another office. You then sent me a letter telling me that I had completed the paper work incorrectly and I had thirty days to re-file and that you had waved the 400.00 penalty for both corporations. So I had my acco. and re-file the paper work. Then I received this letter telling me I owe 400.00.
