
Please find enclosed the 2000 Uniform Business Report for Technoline, Inc. The reason that the report is late is due to the fact that the original report was never received. As the CPA for Technoline, Inc., I moved my office during 1999, and I believe that is the reason that the report was not received. Since the original report was not received, I feel that there is reasonable cause for the late filing.

The mailing address and registered agent address are now correct on the report, to ensure that the report is received in January next year.

This is the first time in 6 years that the report has not been filed by May 1st. Usually the report is filed well before May 1st, and there is every intention that the report is filed on time. I therefore am enclosing a check for the \$150 due with the original notice, due to reasonable cause.
