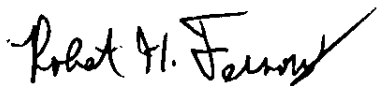

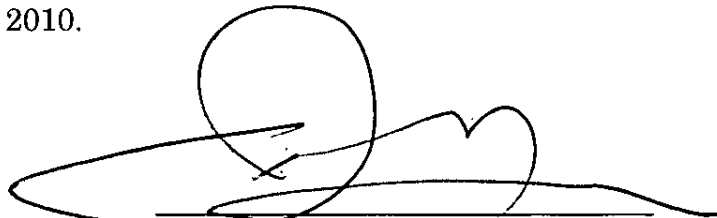
WHEREAS, on October 6, 2010, pursuant to Section 607.1402, Florida Statutes, Jorge L. Arrizurieta and Tony Goitia, the sole Directors and Shareholders of **WESTERN OIL CORPORATION**, a corporation organized under the laws of the State of Florida on July 21, 1994 (the "Company") determined that it was in the best interests of the Company to dissolve the Company;

WHEREAS, pursuant to Section 607.1402, Florida Statutes, the Company took valid action by Unanimous Written Consent of the Board of Directors and Shareholders of Western Oil Corporation approving dissolution of the Company;

WHEREAS, pursuant to Section 607.1403(1), Florida Statutes, the Company seeks to file with the Florida Department of State this Articles of Dissolution with all the required information as follows: (a) Western Oil Corporation; (b) Dissolution was authorized on October 6, 2010; and (c) a vote of all Directors and Shareholders approved the dissolution by unanimous written consent.
