2. Article VI is hereby amended to read as follows:

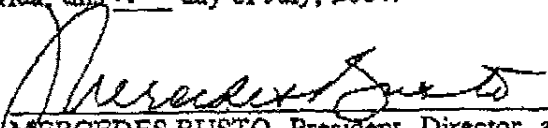
Article VI - Board of Directors
