Pursuant to Florida Statutes Section 607.1006, the undersigned, being the sole shareholder of Busto & Jennings, P.A., hereby amends the Certificate of Incorporation as follows:

1. Article I is hereby amended by deleting the words "Busto & Jennings, P.A." and substituting therefor the words "Mercedes Busto, P.A." Therefore, Article I shall read as follows:
The name of this corporation shall be MERCEDES BUSTO, P.A.

2. Article II is hereby amended to read as follows:

Article II – Purpose

This corporation is organized to engage in any and all lawful business and activities for which corporations may be incorporated under Chapter 607, Florida Statutes.

3. Article VI is hereby amended to read as follows:


Article VI – Board of Directors
