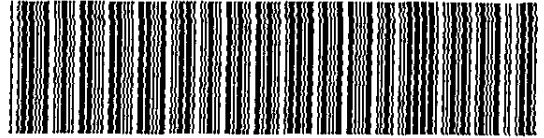

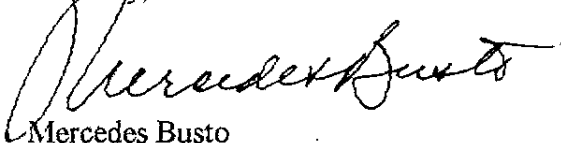

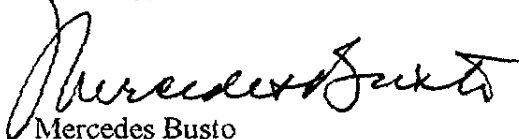

Article IV – Principal Office and Registered Agent

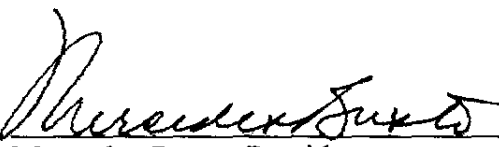
