In response to your letter regarding my 2000 Florida Uniform Business Report, I wanted to write and explain my problem regarding this error. In the early part of 1999 we were living in a R.V. trailer park at 660 Tucker Lane, Cocoa, Fl. 32926. We moved to a mobile home park at 200 S. Banana River Dr. on Merritt Island, Fl. 32952 also in early 1999. I completed the change of address forms for the post office, but was told that the Tucker Lane address was a drop box and mail could not be forwarded. I told them I had business mail for Hair Consultants, Inc. coming to this address. We were told by Post Office that we would have to stop at our old address to pick up the mail. We did this for a year after our move. We did not receive the form in question, as well as, many other items that should have been forwarded. Having already filled out the form and paid for 1999, I did not think about the 2000 form until your letter. I have since had all my business mail sent to my accountant's office at 635 Brevard Ave., Cocoa, Fl. 32922, to avoid this type of thing happening again.

Also in 1999 my husband was very ill, hospitalized a extended period and ultimately had to go on Social Security Disability for permanent lung disease. With the moves and the health problems, I did not realize that I had not filed the form.

I respectfully request that you would abate all penalties and late charges. I am a responsible business person and will make sure that this does not occur again in the future. My accountant and I wondered why I did not receive my bill for 2001. We sent a form copy. I am enclosing my check for my \$150 payment for year 2000. P94000055299
