THE ARTICLES OF INCORPORATION OF

FIRST: The name of the Corporation is FDC PUBLISHING CORP.

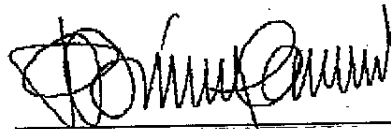
SECOND: "Article I. Name" of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:
