ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
CARGO CONNECTION LOGISTICS HOLDING, INC.

Pursuant to the provision of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to the articles of incorporation:

FIRST: Amendment adopted (indicate articles number being amended, added or deleted)

PARAGRAPH 1 OF ARTICLE IV, CAPITAL STOCK IS AMENDED TO READ AS FOLLOWS:

The Corporation is authorized to issue up to 5,002,000,000 shares of capital stock of which 5,000,000,000 shall be designated as "Common Stock", each shares of which shall have the par value of \$0.001 and 2,000,000 which shall be designated as "Preferred Stock", each of which shall have the par value of \$1.00, except for 8,500 which shall have par value of \$.001.
