

4. That no debts remain unpaid.

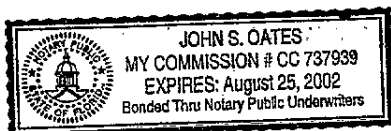
