It will undoubtedly take months to sort it all out, find the form and posting of the money to some wrong account. I am confident that eventually the form will be found in Tallahassee.

My wife and I are trying to help hurricane Mitch victims. I had a meeting in Managua yesterday with the Ministry of Economics. They need my corporate papers tomorrow at their consulate in Miami so that my company can be approved at the next scheduled meeting in Managua of the Ministry on November 10. This is necessary so that we may continue the work we are doing; (not only does Nicaragua make you register to give away financial help, they even charge us a percentage of our donations!) I realize that from your point of view we simply missed the filing deadline. Please understand from our eyes, we sent the paper (obviously lost) and check (made out to the wrong department). I need this CB 2 corporation to be in good standing when the Miami Nicaraguan consul checks it in a few days. The money you normally charge for my mess represents a year's food for 42 people in the mountains of Nicaragua. Please give this request your immediate consideration. An email or call tomorrow will be of great help, as I am stopped in our aid efforts until this corporation is once again in good standings. I leave this Sunday again. I apologize for all the confusion and must attribute it to my aging or trying to do too much.
