Re: Kiwi, Inc. reinstatement and Articles of Amendment to Articles of Incorporation

Dear Addressee:

We represent the Corporation known as Kiwi, Inc., which had been administratively dissolved by the Department of State several years ago after it had not filed the Annual Corporate Report. It was later determined that the Annual Report Notice had come back to the Secretary of State's office, and now we are sending the necessary documents to place it back in good standing.

We are also advised that the corporate name, Kiwi, Inc., has been taken by another corporation, and therefore we have had the stockholders and directors approve Articles of Amendment to the Articles of Incorporation of Kiwi, Inc., which were originally filed on August 12, 1994, with document no. P94000059582. The Articles of Amendment are enclosed herewith and have changed the name to Kiwi of Gainesville, Inc., which I have been advised by the person in the Department of State that such a name change is sufficient.

I am enclosing the following documents:

1. Articles of Amendment;
2. Corporation Reinstatement form, which is hopefully properly filled out, and which has been signed by Douglas T. Fouts, as both registered agent and as president of the Corporation on March 9, 2004;
3. Certificate Designating Place of Business or Domicile for the Service of Process Within this State, Naming Agent Upon Whom Process May be Served, and which shows that the Corporation has named Douglas T. Fouts, with the business address stated, as its registered agent. It is my understanding that Mr. Fouts has always served as the registered agent, but I wanted to be sure that there is no issue with this being done. I am enclosing our firm's checks made payable to the Department of State in the respective amounts of \$608.75, which is for the reinstatement fee (\$600.00) and to pay for a Certificate of Status, (\$8.75) as told to me by Marquitta

in the office of the Department of State, with whom I spoke, and a check made payable to the Department of State in the amount of \$35.00 to pay for the Amendment to the Articles of Incorporation.

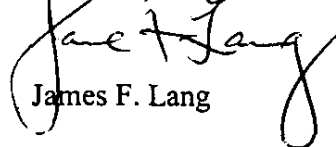
