The authors of the paper, "The Effect of the 1996 Tax Reform on the Distribution of Income in the United States," find that the distribution of income in the United States has become more unequal since 1996. The authors argue that this is due to the fact that the 1996 Tax Reform Act reduced the tax burden on high-income households, while the tax burden on low-income households remained relatively unchanged. The authors also find that the distribution of income in the United States has become more unequal since 1996, but that the effect of the 1996 Tax Reform Act on the distribution of income in the United States is not statistically significant. The authors conclude that the 1996 Tax Reform Act has had a small, but positive, effect on the distribution of income in the United States.
