ARTICLES OF AMENDMENT OF MUVICO PALM HARBOR, INC.

99 MAY 17 PM 12: 40 TALLAHASSEE, PLORIDS

ITEM I.

Article IV of the Articles of Incorporation of MUVICO PALM HARBOR, INC., a Florida corporation, is hereby amended to read in its entirety as follows:

ARTICLE IV - Capital Stock

This Corporation is authorized to issue One Hundred Twenty Million (120,000,000) shares of no par value common stock, which shall be designated "Common Shares".

ITEM II.

Without any further action required to be taken, each share of common voting stock of the Corporation of the par value of \$1.00 each which is issued and outstanding or held in the treasury of the Corporation as of the filing and effectiveness of these Articles of Amendment shall immediately upon the filing and effectiveness of the foregoing Articles of Amendment be reclassified and changed into 100,000 fully paid and non-assessable shares of common stock of the Corporation having no par value.

ITEM III.

The foregoing Amendment was adopted by all of the shareholders and directors of this corporation on November 2, 1998.
