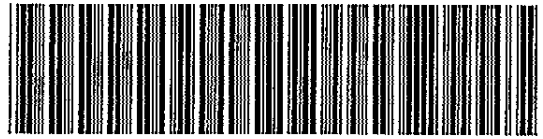

ROBERT A. KRAMER, P.A.

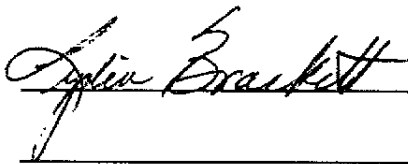

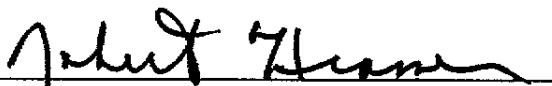

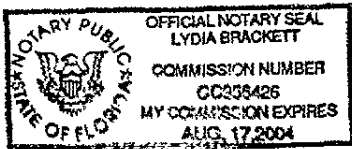
