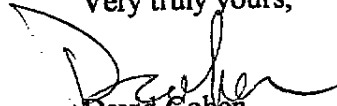

ARTICLES OF AMENDMENT OF THE  
ARTICLES OF INCORPORATION  
OF  
LAQUIDARA & EDWARDS, P.A.

Pursuant to the provisions of Chapters 620 and 607, Florida Statutes, Laquidara & Edwards, P.A., a professional corporation organized under the laws of the State of Florida (the "Corporation"), hereby adopts the following amendments to its Articles of Incorporation.

FIRST, the name of the Corporation is Laquidara & Edwards, P.A., the original Articles of Incorporation of which were filed with the Florida Department of State on or about August 9, 1994.

SECOND, the original Articles of Incorporation are hereby amended by deleting ARTICLE I in its entirety and replacing it with the following:

ARTICLE I  
NAME

The name of the Corporation is Laquidara, Edwards, Cohen & Jacobs, P.A. The address of the principal office, and the mailing address, of the Corporation is 200 North Laura Street, Twelfth Floor, Jacksonville, Florida 32202.

THIRD, each reference in the original Articles of Incorporation to "Laquidara & Edwards, P.A." shall on and after the date hereof be deemed to be a reference to the Corporation as renamed herein.

FOURTH, clause (a) of ARTICLE VI of the original Articles of Incorporation is hereby deleted in its entirety and replaced by the following:

(a) Number. This corporation shall have three directors; provided that the number of directors may be increased or decreased by the bylaws from time to time so long as the number thereof is not less than the lesser of (i) the number of shareholders of the corporation or (ii) three.

The date of adoption of these Articles of Amendment is October 31, 1997, on which date the within amendments were unanimously approved by all of the shareholders and all of the directors of the Corporation at a meeting attended by all of the directors and shareholders without objection. Said amendments and these Articles of Amendment were approved by the requisite number of shareholders of the Corporation.
