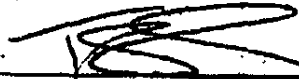
ARTICLES OF DISSOLUTION

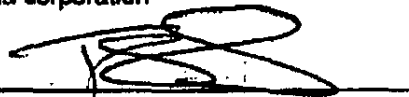
