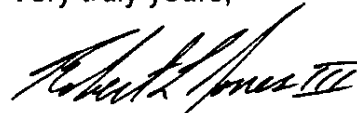

A. The name of this Company is **R. ROBERTS GALLERY INC.**

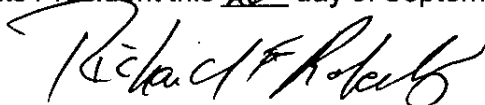
B. Article I of the Articles of Incorporation is amended to change the name of the Company to:
