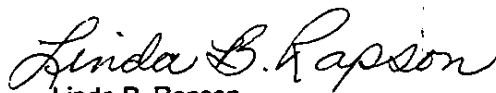

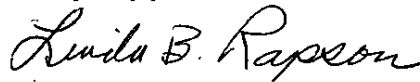
During a telephone conversation with your office today, it was recommended that this letter be written to explain the events leading to filing the enclosed second 2001 UNIFORM BUSINESS REPORT. I have also enclosed Xerox copies of the various correspondences.
