I am writing to you on behalf of Mr. Lai Lu, President of Canton One Restaurant, Inc., who has asked me to write to you for him. He does not speak or read English well enough to contact you himself. Please consider this his official request to abate any reinstatement fee for 1998.

During 1998 he was robbed. He has no way of knowing what paperwork or mail was taken that he had not yet had someone read for him. In addition, he moved from Ocala to Orlando. As far as he knows, he never received the notice warning him he was going to be dissolved. It was not until you returned his 1999 Annual Report that we became aware that no report for 1998 had ever been received by the Division of Corporations. All his tax mail and corporate mail having to do with such things as required reports and filings is now coming to my P. O. Box so something like this cannot happen again in the future. Mr. Lu has tried very hard to comply with everything the law requires. Please look favorably upon his request for abatement of any reinstatement fees and accept his reinstatement for 1998 and Annual Report for 1999 along with the \$150 filing fees for each year.

Enclosed is his 1998 reinstatement request along with a check for \$150. We are also returning to you his 1999 report along the check for \$150 that you sent back to him when you notified him that no 1998 report had been received by your office.
