The undersigned, acting in his capacity as the Vice President of Alpha Computer Services, Inc. (the "Corporation"), a Florida corporation, on behalf of the Corporation, has executed these Articles of Amendment to the Articles of Incorporation (the "Articles of Amendment"), as unanimously approved and adopted by the Board of Directors of the Corporation in an action by written consent on March 20, 2000 and as unanimously approved by the shareholders in an action by written consent on March 20, 2000, which number of votes cast was sufficient for shareholder approval.

These Articles of Amendment amend the Corporation's Articles of Incorporation, as filed with the Florida Department of State on August 30, 1994. These Articles of Amendment increase the shares available for issuance.

ARTICLE I - NAME

The name of this Corporation is Alpha Computer Services, Inc.


ARTICLE II - AMENDMENT
