Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts or amends the following articles to its articles of incorporation:

FIRST: Amendment(s) adopted or amended:

Article II PRINCIPLE OFFICES

Principle offices of the corporation are 3108 Saratoga Dr., Kissimmee, Fl. 34743.
