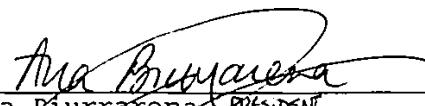

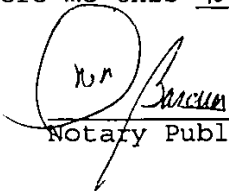

a) Change of Name

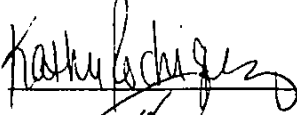

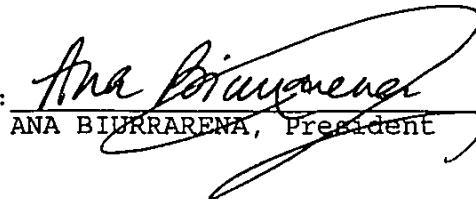

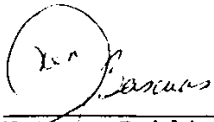
