In response to your letter dated July 29, 1998, the following explanation is offered:

All incoming mail is logged in and separated into four categories - 1) Accounts Receivable; 2) Accounts Payable; 3) Reports To Be Completed/Submitted and 4) "for Review". Only Mr. Hance, President/Owner, Jo Ann Hance, Bookkeeper/Registered Agent, and LedgerPlus (Accountant) handle the mail. Not one of three persons had ever seen the initial (first) Annual Report.
