ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SOUTH LUBES, INC.

Pursuant to the provisions of Section 607.1006 of the Grand Corporation Act, the undersigned corporation adopts the following Amendments to its Articles of Incorporation:

- 1. Article IV (A.) is hereby amended and changed as follows:
- A. <u>Authorized Capital</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 20,000 shares of common stock having a par value of \$1.00 per share.
