THE UNDERSIGNED, KURT J. LONG, being the President of OPENNET TECHNOLOGIES, INC., does hereby certify that the following Amendment to the Articles of Incorporation of OPENNET TECHNOLOGIES, INC. was approved by the Stockholders of said Corporation on the 5<sup>th</sup> day of May, 1997, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of OPENNET TECHNOLOGIES, INC. are hereby amended as follows:

- 1. Article 6.1 is hereby deleted and the following is inserted in lieu thereof:
- 6.1. The maximum number of shares that this Corporation is authorized to have outstanding at any time is Three Million, Five Hundred Thousand (3,500,000) shares of common stock, each share having no par value.
- 2. All amendments included herein were adopted  $\frac{5}{3}$   $\frac{5}{5}$ , 1997, pursuant to Section 607.1004, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.
- 3. This Amendment has been approved by unanimous consent of all of the Shareholders of the Corporation who are entitled to vote the  $5^{7}$  day of  $50 \times 2$ , 1997.
- 4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
