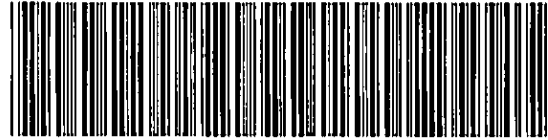

ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is C N R INC OF SOUTH FLORIDA

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To engage in the business of marketing consulting.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.

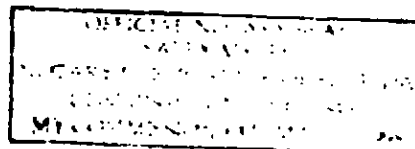
