

## AMENDED AND RESTATED ARTICLES OF INCORPORATION OF STAR ELECTRIC DISTRIBUTORS, INC. a Florida Corporation

TALLARIASSEE OF ORIGINATION OF THE PROPERTY OF

The undersigned, officers of STAR ELECTRIC DISTRIBUTORS, INC., a Florida corporation ("Corporation"), pursuant to Section 607.1006 and 607.1007 of the Florida Statutes, hereby amend and restate in its entirety the Articles of Incorporation for the Corporation:

#### ARTICLE I NAME

The name of the Corporation is STAR ELECTRIC DISTRIBUTORS, INC.

## ARTICLE II OFFICE AND MAILING ADDRESS

The principal office of the Corporation is located at 7540 NW 66th Street, Miami, Florida 33166, and the mailing address of the Corporation is c/o Ivan A. Gomez, P.A., 601 Brickell Key Drive, Suite 507, Miami, Florida 33131.

### **ARTICLE II DURATION**

The Corporation shall have perpetual existence.

#### <u>ARTICLE III</u> <u>PURPOSE</u>
