Please find a check in the amount of \$300, which represents the filing fees for both 2001 and 2002. I am requesting that you waive the reinstatement fee for the following reason:


I filed and paid my 2000 UBR fee on a timely basis. Since the check for \$150 cleared in May 2000, I assumed everything was fine.

It was not until last week that I became aware there was a problem. When my accountant asked if I had mailed in my 2002 filing fee, I realized not only had I not received this year's UBR, but I also had not received 2001's UBR.

Upon further research I discovered the problem dated back to my 2000 filing. According to your office, the 2000 report was not properly signed. Although the check was cashed, the filing was rejected and returned to my address. Unfortunately, my suite number (# F-2) was not included on the notice and I never received it. Your office sent a second notice to the old registered agent and I was never notified.

Had I been notified, 2000's report would have been signed correctly, then I would have received and paid 2001's report the following year. This is why I have included payment for both last year's and this year's UBR, and the reason why I am requesting that you waive the reinstatement fee.
