ARTICLE III


All shareholders approved the dissolution of the Corporation; accordingly the number of shares cast for dissolution was sufficient for approval. Voting by voting group was not required.



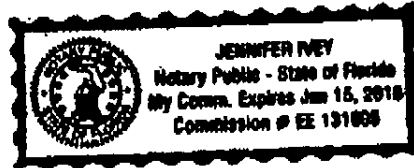
