I, the undersigned, ROBERT YERBY, President of NETJUICE CONSULTING, INC., a corporation organized and existing under the laws of the State of Florida (hereinafter referred to as the "Corporation") hereby certify and affirm that the Corporation has duly adopted the following amendment to its Articles of Incorporation pursuant to ' 607.1006:

1. The name of the Corporation is NETJUICE CONSULTING, INC.
2. Article I of the Corporation's Articles of Incorporation is hereby amended to read as follows:

**ARTICLE I - NAME**

The name of this corporation is INITIATIVES CORPORATION.

3. A majority of the shareholders approved the Amendment on August 6, 2001.

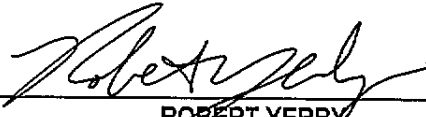
