Adequate provision has been made for the payment of all of the liabilities and obligations of the Corporation.

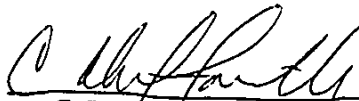

There are no actions pending against the Corporation in any court.

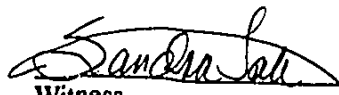

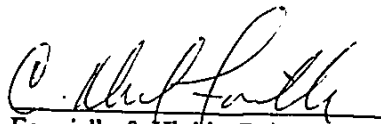
