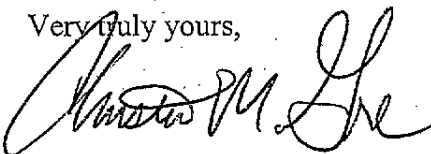

1. The name of the corporation is PBSM EQUIPMENT COMPANY, Inc.

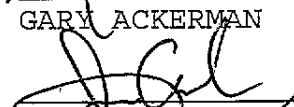

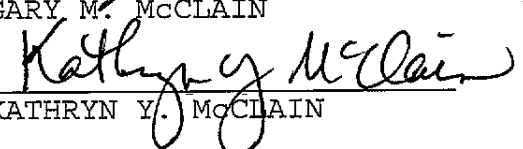
