ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF JAMES K. SHEA, M.D., P.A.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name
