Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendments to its articles of incorporation:

ARTICLE I NAME

The corporation will change its name to SURGIKAL, INC.

Victor N. Suarez	15 shares	\$150.00

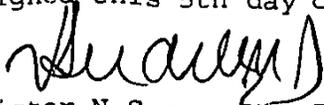
Should read as follows:

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new common stock of this corporation, shall have the right to purchase their prorated shares (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

These articles of amendment were adopted on the 5th day of February, 1997. The corporation has only one group of voting stock. All shareholders of said group, unanimously casted their votes for the amendments.
