ARTICLES OF AMENDMENT

1. In accordance with Chapter 607, Section 1001, of the Florida Business Corporation Act, the following provisions of the Articles of Incorporation of Prosperity Cleaners & Laundry, Inc., a Florida corporation (the "Corporation"), filed with the Office of the Secretary of State of the State of Florida on October 4, 1994 be, and they hereby are, amended as follows:
