ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF BUTENSKY & COHEN FINANCIAL SECURITY, INC.

 - "Section 5. No shares of the Class A Voting common stock or the Class B Non-Voting common stock shall be issued in bearer form and the Corporation is herein specifically prohibited from issuing the same in the form of a bearer instrument."
- 3. The last sentence of Article XII is hereby deleted in its entirety.
- 4. In all other respects except as specifically changed and modified in these Articles of Amendment to the Articles of Incorporation, all of the provisions contained in the Articles of Incorporation of Butcusky & Cohen Financial Security, Inc. shall be and remain the same.
