ARTICLES OF AMENDMENT TO

ARTICLES OF INCORPORATION OF

BRIDGEFIELD CASUALTY INSURANCE COMPANY

Pursuant to the provisions of Section 607.1006, Florida Statutes, Bridgefield Casualty Insurance Company, a Florida for-profit corporation ("Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The address of the principal place of business of the Corporation as set forth at Article 1, entitled "Name" is amended to be:

2310 Commerce Point Drive Lakeland, FL 33801

The Corporation may establish and maintain the principal place of business of the Corporation at such other place within the State of Florida or elsewhere as may be determined from time to time by the Board of Directors.

2. Paragraph one of Article III, entitled "Capital Stock" is amended to read:
