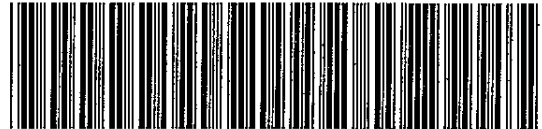

The dissolution of the corporation, **AIRPLANE OPERATIONS, INC.**, was authorized on December 31, 2003.


ARTICLE II
