



Article X of the Articles of Incorporation is hereby deleted and replaced in its entirety with the following:

"X. Registered Agent.

A new Article XII is hereby inserted in the Articles of Incorporation as follows:

## "XII. Bankruptcy Matters

The corporation shall not take any of the following actions without the unanimous written consent of the Board of Directors and the shareholders representing at least a majority of the outstanding shares of the corporation: filing a voluntary petition for relief under title 11, United States Code (11 U.S.C. §101 et seq.) (the "Bankruptcy Code") or any other federal or state bankruptcy or insolvency law; filing, or joining in the filing of, an involuntary petition under the Bankruptcy Code or any other federal or state bankruptcy or insolvency law, or soliciting petitioning creditors for any involuntary petition filed against the corporation under the Bankruptcy Code or any other federal or state bankruptcy or insolvency law, or soliciting petitioning creditors for any involuntary petition; consenting to, or acquiescing in, or joining in, any application for the appointment of a custodian, receiver, trustee, or examiner with respect to the corporation or any portion of the assets of the corporation in excess of \$10,000; or making an assignment for the benefit of creditors or admitting, in writing or in any legal proceeding, insolvency or inability to pay debts as they become due."

This Amendment was adopted on the 26 day of Avg, 2011, by the board of directors and the shareholders of the Corporation. The number of votes cast for the amendment by the board of directors and the shareholders was sufficient for approval.
