1. The name of the corporation is Buena Vista Wood Products, Inc.

2. The following amendments of the articles of incorporation were adopted by the shareholders and directors of the corporation on March 5, 1998, in the manner prescribed by the Florida General Corporation Act:

B. The name and address of the sole director who will hereafter constitute the Board of Directors is:

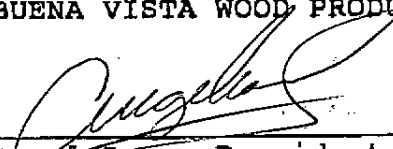
