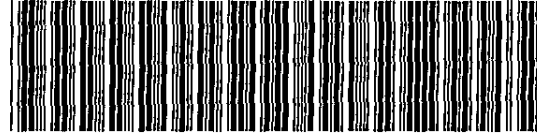


THIRD: The date of each amendment's adoption: **April 16, 2003**
