**ARTICLES OF MERGER OF COMPUTE ABILITY, INC., a Florida Corporation,  
With and Into COMPUTERS, INC., a Florida corporation**

Pursuant to and in accordance with the provisions of Section 607.1101 of the Florida Business Corporation Act, COMPUTE ABILITY, INC., a Florida corporation, adopts the following Articles of Merger for the purpose of merging it with and into COMPUTERS, INC., a Florida corporation, registered to do business in Florida, as the surviving corporation:

1. The names of the corporations which are parties to the within merger are COMPUTE ABILITY, INC., a Florida corporation, and COMPUTERS, INC., a Florida corporation. COMPUTERS, INC., a Florida corporation, is the surviving corporation.

2. 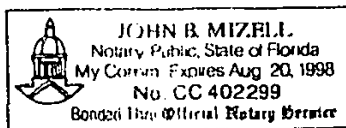

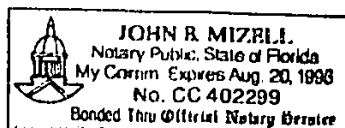
