Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, Walker & Company Construction Services, Inc., a corporation organized and existing under and by virtue of the Florida Business Corporation Act (the "Corporation") does hereby certify:

- 1. The name of the Corporation is Walker & Company Construction Services, Inc.
- 2. The original Articles of Incorporation for the Corporation were filed on October 21, 1994, and assigned Charter No. PQ4000077525.
- 3.
