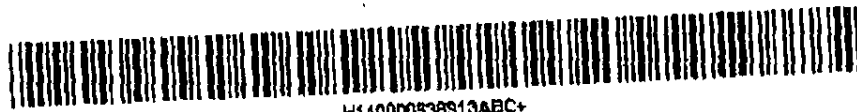

Pursuant to the provisions of Sections 607.1402 and 607.1403, Florida Statutes, Alliance Medical Practices, Inc., a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution:

1. The name of the Corporation is Alliance Medical Practices, Inc., and its document number is P94000078379.
2. The dissolution was authorized and approved by unanimous vote of the Board of Directors of the Corporation and by unanimous vote of the Board of Directors of its sole shareholder on January 9, 2014, and approved by the Board of Directors of SantaFe HealthCare, Inc. on February 26, 2014. Authorization by the Board of Directors of the Corporation and its sole shareholder, together with approval by SantaFe HealthCare, Inc. are sufficient for the dissolution of the Corporation.
3. The Corporation has made adequate provisions for all debts, obligations and liabilities of the Corporation, including the distribution of all remaining property and assets to the sole shareholder in liquidation.
4. There is no litigation pending against the Corporation in any court.
5. The dissolution of the Corporation is intended to be effective on December 31, 2013 for accounting and tax purposes, notwithstanding the later filing of these Articles of Dissolution with the Florida Department of State.
