

ARTICLE V.



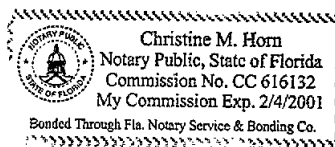
