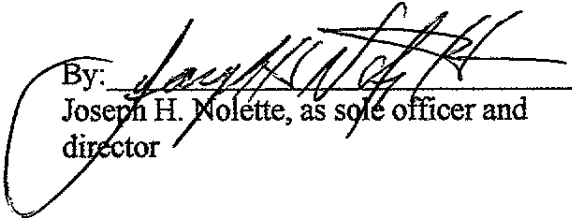
1. The name of the corporation is LAKE-SUMTER FINANCE COMPANY.

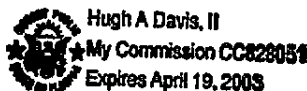

BY WRITTEN CONSENT OF ALL THE SHAREHOLDERS

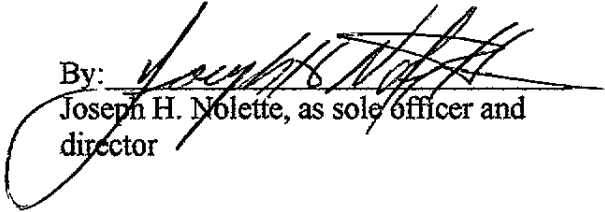
