Amendment to Articles of Incorporation

The Articles of Incorporation of Eastrich No. 157 Corporation are amended as follows:

The first sentence of Article II of the Articles of Incorporation of Corporation is amended (such amendment to be deemed effective as of the initial date of incorporation of the Corporation) to provide as follows:

"The Corporation is organized for the exclusive purpose of (i) acquiring real property and holding title to, and collecting income from, such property, (ii) remitting the entire amount of income from such property (less expenses) to one or more organizations which are (a) qualified pension, profit sharing, or stock bonus plans that meet the requirements of Section 401(a) of the Internal Revenue Code, as amended (the "Code"), (b) the United States, any state or political subdivision thereof, or any agency or instrumentality of the foregoing, (c) a governmental plan (within the meaning of Code Section 414(d)), or (d) any organization described in Code Section 501(c)(3), and (iii) doing, exercising and performing any act, thing or power necessary, suitable, or desirable for the accomplishment of the foregoing purposes, or the attainment of any objectives or the furtherance of any powers which are lawful purposes, objectives or powers of a corporation organized under Chapter 607 of the Florida Statutes and which may be permitted a corporation exempt from federal income tax under Code Section 501(c)(25)."

The foregoing amendment has been approved by the directors and shareholders of the Corporation.
