ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
WRP ACQUISITION COMPANY

Pursuant to the provisions of Florida Statute Section 607.1006, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is WRP Acquisition Company.
2. This first sentence in Section B. Common Stock under Article IV (Capital Structure) is hereby revised as follows:

ARTICLE IV
CAPITAL STRUCTURE

B. Common Stock

The total number of shares of common stock which the Corporation shall have the authority to issue is 2,000,000 shares consisting of: 1,800,000 shares of Class A Voting Common Stock, with a par value of One Cent (\$0.01) per share (herein called the "Class A Common Stock"), and 200,000 shares of Class B Nonvoting Common Stock, with a par value of One Cent (\$0.01) per share (herein called the "Class B Common Stock").

3. This amendment to the Articles of Incorporation of WRP Acquisition Company was unanimously adopted by the shareholders of the Corporation on June 28, 1996.
