



### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BENGE CORP.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **BENGE CORP.**, a Florida corporation (the "Corporation"), does hereby certify as follows:
